"Bhartiya Janraj Party" - Registration under Section 29A of the Representation of the People Act, 1951, as a political party - Regarding.

Sir,

I am directed to state that the Election Commission of India, after having considered your application dated 20.04.2018 for registration of "Bhartiya Janraj Party" as a political party and the documents produced in support of the statements/averments made/contained in the said application and the submissions made by authorized representative(s) of the party before the Commission on 18.12.2018 in respect of the said application and having noted that no objection has been filed by anyone to the registration of the Party under the said name in response to the Public Notice published by the applicant in the newspapers, has registered the "Bhartiya Janraj Party" as a political party under Section 29A of the Representation of the People Act, 1951 on and with effect from 16.01.2019.

- 2. The Registration Number of your party is 56/165/2018-19/PPS-I.
- As provided in sub-Section (9) of Section 29A of the Representation of the People Act, 1951, the party shall communicate to the Commission without delay any change in its name, head office, office-bearers, address or in any other material matters. The communication of such changes shall be accompanied by the following:
 - (i) An authenticated copy of the resolution passed by the competent body prescribed in the party constitution and the full proceedings of the meeting at which the decision of such changes is taken.

(ii) Names of the office-bearers attending the said meeting.

(iii) An attested copy of the extract of attendance register bearing signature of participating members in the said meeting.

- 4. It may be noted that the registration will not entitle the party to the reservation of any exclusive symbol for it. The candidates duly set up by the party at an election will be entitled to benefits of preference in allotment of free symbols over independent candidates under paragraph 12 of the Election Symbols (Reservation & Allotment) Order, 1968. However, under the provisions of paragraph 10B of the Symbols Order, the candidates set up by a registered unrecognized political party contesting from a minimum of 5% of the seats, at a general election to the Legislative Assembly of a State or to the House of the People, may be allotted a common symbol from the list of free symbols, provided the Party fulfills each of conditions mentioned in the said Para 10B.
- As per the provisions of Section 29B and 29C of the Representation of the People Act, 1951 (dealing with contribution to political parties) the party is required to submit to the Commission, a report of contribution received in excess of Rs. 20,000/- in a financial year, in the format in Form 24A appended to the Conduct of Elections Rules, 1961. In such report, the party has to mention the Permanent Account Number (PAN) of the party. Therefore, you are advised to obtain Permanent Account Number (PAN) in respect of the party and inform the details of the same to the Commission within six months of the registration.
- 6. It is also informed that the Commission, while registering a political party, does not approve the flags of political parties, and if the party has a flag, it shall be the own responsibility of the party to ensure that the flag does not violate the provisions of the Emblems and Names (Prevention of Improper Use) Act, 1950 or the flag Code of India or any other relevant law related to the subject, and that its flag does not imitate in any manner the flag of any other political party.



मुझे यह कहने का निदेश हुआ है कि भारत निर्वाचन आयोग ने "भारतीय जनराज पार्टी" का राजनैतिक दल के रूप में पंजीकरण करने के लिए आपके दिनांक 20.04.2018 के आवेदन और उक्त आवेदन-पत्र में विवरण/प्रकथन के समर्थन में प्रस्तुत कागजातों और दल के प्रतिनिधि/प्रतिनिधियों द्वारा उक्त आवेदन के संबंध में दिनांक 18.12.2018 को आयोग के समक्ष दी गई प्रस्तुतियों पर विचार करने के बाद तथा यह ध्यान में रख कर कि समाचार पत्रों में आवेदक द्वारा प्रकाशित पब्लिक नोटिस के जवाब में उक्त नाम से पार्टी के पंजीकरण पर किसी भी व्यक्ति के द्वारा कोई आपित्त दर्ज नहीं की गई है, लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 29क के अधीन "भारतीय जनराज पार्टी" को दिनांक 16.01.2019 से राजनैतिक दल के रूप में पंजीकृत कर लिया है।

- 2. आपके दल की पंजीकरण संख्या 56/165/2018-19/रा0द0अनु0-1 है।
- 3. लोक प्रतिनिधित्व अधिनियम,1951 की धारा 29क की उपधारा (9) में यथा उपबंधित दल अपने नाम, मुख्यालय, पदाधिकारी, पते या अन्य किसी तात्विक मामले में, यदि कोई हो तो, किसी प्रकार के परिवर्तन की सूचना आयोग को शीघ्र देगा। इस प्रकार के परिवर्तन की सूचना निम्नितिखित दस्तावेजों के साथ भैजी जाएगी:-
 - (i) दल के संविधान में निर्धारित सक्षम समिति द्वारा पारित किए गए संकल्प तथा उस बैठक का सम्पूर्ण कार्यवृत जिसमें ऐसे परिवर्तन/संशोधन का निर्णय लिया गया है, कि एक प्रमाणित प्रति।
 - (ii) उपरोक्त बैठक में उपस्थित पदाधिकारियों के नाम की सूची।
 - (iii) उपरोक्त बैठक में उपस्थिति रजिस्टर का उद्धरण (extract)जिसमें भाग लेने वाले सदस्यों के हस्ताक्षर हों, की एक प्रमाणित प्रति।

- 4. यह भी उल्लेखनीय है कि यह पंजीकरण दल को किसी अन्य चिन्ह को आरक्षित करने का अधिकार नहीं देता है। निर्वाचन प्रतीक (आरक्षण और आवंटन) आदेश, 1968 के पैरा 12 के अधीन निर्वाचन में दल द्वारा विधिवत रूप से खड़े किए गये अभ्यर्थी, मुक्त प्रतीकों के आवंटन में निर्दलीय अभ्यर्थियों के उपर वरीयता का लाभ पाने के पात्र होंगे। तथापि, प्रतीक आदेश के पैरा 10 ख के प्रावधानों के अधीन लोक सभा या राज्य की विधान सभा के साधारण निर्वाचन में कम से कम 5% सीटों से चुनाव लड़ने वाले पंजीकृत गैर-मान्यता प्राप्त राजनैतिक दलों द्वारा खड़े किए गये अभ्यर्थियों को मुक्त प्रतीकों की सूची में से एक ही प्रतीक आवंटित किया जाएगा, बशर्त कि पार्टी उक्त पैरा 10 ख में उल्लिखित प्रत्येक शर्त को पूरा करती हो।
- 5. लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 29ख और 29ग के प्रावधानों के अन्तर्गत (राजनैतिक दलों को अंशदान से संबंधित), दल को एक वित्तीय वर्ष में रू० 20,000/- से अधिक प्राप्त संदान/अंशदान के बारे में निर्वाचनों का संचालन नियम, 1961 में संलग्न प्रारूप 24क में एक रिपोर्ट आयोग में प्रस्तुत करना आवश्यक है। ऐसी रिपोर्ट में दल की स्थायी खाता संख्या (PAN) का विवरण देना होता है। अतः आपको यह सलाह दी जाती है कि आप अपने दल का स्थायी खाता संख्या (PAN) प्राप्त कर आयोग को उसका विवरण दल के पंजीकरण से छः माह के भीतर सूचित कर दें।
- 6. यह भी सूचित किया जाता है कि किसी राजनैतिक दल का पंजीकरण करते समय आयोग राजनैतिक दलों के ध्वजों को अनुमोदित नंहीं करता है और यदि दल का अपना ध्वज है तो यह उस दल की जिम्मेदारी होगी कि वह यह सुनिश्चित करे कि वह संप्रतीक और नाम (अनुचित प्रयोग निवारण) अधिनियम, 1950 या भारत के फ्लैंग कोड अथवा इस विषय से संबंधित अन्य किसी सुसंगत विधि के उपबंधों का उल्लंघन न करे और यह भी कि उसका ध्वज किसी अन्य राजनैतिक दल के ध्वज का किसी भी प्रकार से अनुकरण न करे।

- 2. To fight/agitate for the protection of fundamental and human rights of the Indian citizens or abroad.
- 3. To take, as political party active part in election.
- 4.To organize meetings and rallies, and to take part in the various media, source. For the purpose of creating awareness of political rights of Citizens/individuals in the purpose of creating awareness of political rights of Citizens/individuals in India.
- 5.To form/establish, if necessary, various branches of the political party for the purpose of protecting fundamental/ other rights of the citizens.
- 6.Employment of the weaker sections through affirmative action in favour of the disadvantaged sections of the society namely the scheduled castes, the scheduled tribes, Other Backward Classes, women and disabled.
- 7. Maintaining the unity and integrity of India by building up on the concept of unity in diversity and by strengthening federalism with decentralization of power consistent with the Gandhian concept of taking it right it right down to the village level.
- 8. Promoting economic growth and prosperity through competition, self reliance, individual initiative and enterprise with emphasis on equity and social justice.
- 9. The Income of the party on by whatever means shall utilized for the objects of the society and shall not be distributed among the members or anybody.

Name: Article I.

The name of the party shall be Bhartiya Janraj Party.

Article II.

The registered head office of the party shall be situated at

AIMS AND OBJECTIVES

Article III.

a

- 1. To protect social, economic and political rights of the citizen of India.
- 2. To fight/agitate for the protection of fundamental and human rights of the India citizens or abroad.
- 3. To take, as political party, active part in any election.
- 4.To organize political meeting and allies and to take part in the various media sources for the purpose of creating awareness of political rights of citizens/Individuals in India.
- 5.To form/establish, if necessary, various branches of the political party for the purpose of protecting fundamental/ other rights of the citizens.

Allegiance to the constitution of India.

The Bhartiya Janraj Party shall bear true faith and allegiance to the Constitution of India as by law established and to the principles of socialism, secularism and democracy and would uphold the sovereignty, unity and integrity of India.

- B) Party Constitution Provides:
 - a) Periodic regular election will be to all office/committees and office bearers.
 - b) Democracy, Socialism & Secularism as basic tenets of the party.
 - c) Party will not in any manner promote or instigate or participate any violence.
 - d) The party must contest an election conducted by the Election Commission within five years of its registration and thereafter should continue to contest.

Membership

Article IV

Bhartiya Janraj Party shall have a two tier membership pattern; Party Cadre and Party Member.

Party Cadre

Any citizen of India eighteen (18) years of age or above who is willing to associate with the party will be a Party Member. Any person irrespective of religion, caste, creed and sex may be admitted as a Party Member. A Member has no right to elect office bears or to be elected as office bearers or to vote on any motion or resolution.

Membership Subscription: Member should pay Triennial membership fee of Rs.10/- only. The triennial subscriptions paid by members shall be distributed in the following ratios between the various committees EC. 25% ,SCs 25% ,District Committee 25% Other Subordinate Committee 25% .The party shall maintain a register of members containing the names father's name address and their occupations, date of birth, the date of admission and the date of cessation. The Register will be kept open for inspection of the members of the Party on requisition.

Jurisdiction

The Jurisdiction of the Party is Indian Union of India\

Pledge

I accept the aims and objectives of the **Bhartiya Janraj Party** and I am ready to work for the fulfillment of civil right and social justice to all citizen of India. I shall abide by the constitution and discipline of the Party. I hereby pledge that I shall give priority to the interests of the people and shall keep away from personal vice and social evils.

Record

The party shall have the following records to be maintained by the Local Branch Committee.

- 1. Party Constitution
- 2. Register of Cadres
- 3. Minute of the Branch Committee meetings.
- 4. Accounts of the respective Committee.

All other higher committees in the hierarchy up to the Executive Committee have to maintain the following records.

- 1. Party constitution
- 2. Minute of the respective Committee meetings.
- 3. Accounts of the respective Committee.

Structure

Article V

1. National Representative Council is constituted by the elected members of the State Working Committee excluding the ex-officio and nominated members and councilors elected as per the ratio of the Party Cadres prescribed from to time for a period of 3 year. The State Representative Councils have to meet once in a year. It will make an annual review of the situation in the Nation and the Party. Executive Committee has to submit the annual report of the Party activities to the National Representative Council for discussion and suggestions. It has power to veto any amendments to the Party Constitution with two third majorities of the members present and voting.

1.a) Executive Committee

The Executive Committee is constituted by minimum 7 and not more than 51 members including President, Vice-President, General Secretary, Treasurer elected by the National Representative Council for a time period of 3 years. The State Presidents shall be exofficio members, if they are not elected members. However the ex-officio members shall not have voting rights. In addition the Executive Committee may nominate members to the committee provided the total number of nominated members does not exceed 1/3 of existing elected months. If demanded by two third members,/it shall be convened within a month of such prior notice. The following shall be the main functions of. Executive Committee.

To discuss and decide on the policy of the Party.

To amend the Party constitution and formulate the Party programmer.

To supervise Party administration and finances.

2. State Representative Councils.

State Committee Council is constituted by the elected members of the District Working Committees excluding the ex-officio and nominated members and councilors elected as period of three years. The District Representative Council has to elect councilors to the State Representative Council. The State Representative Council has to meet once in a year. It will make an annual review of the situation in the State and the Party. State Working Committee has to submit the annual Report of the Party activities to the State Representative Council for discussion and suggestions.

2. a) State Working Committees.

The State Working Committee is constituted by minimum 7 and not more than 31 members elected by the State Representative Council for a period of three years. The District Presidents shall be ex-officio members, if they are not elected members. However the ex-officio members to shall not have voting rights, In addition the State Working committee may nominate members to the committee provided the total number of nominated members does not exceed 1/3 of the existing elected members. The state level decision making body of the Party shall be the State Working Committee. State Working committee shall be convened once in every four months. If demanded by two third members, it shall be convened within 15 days of such a prior notice. The State Working committee has power to veto any decision taken by the State Secretariat.

2.b) State Secretariats.

The State Secretariat is constituted by minimum 5 and not more than 7 members including President and General Secretary in charge of State Office administration, elected by the State Working Committee from among its members. The State Secretariat is the sub-committee of the State Working Committee appointed for the running of the routing affair of the Party. The State Secretariat has to meet at least once in two months.

District Representative Councils

District Representative Council is constituted by the elected members of the Constituency Committees excluding the ex-officio and nominated members and councilors elected as per the ratio of the Party Cadres prescribed from time for a period of three years. The Constituency Councils have to elect councilors to the District Representative Council. In the absence of constituency level structure in any District, it is constituted by the elected member of the immediate lower structure in the hierarchy. The District Representative Council has to meet once in six months. It will make a review of the Party situation in the respective district.

3.a) District Working Committee.

The District working Committee is constituted by minimum 7 and not more than 21 members elected by the District Representative Council more than 21 members elected by the District Representative Council for a period of three years. The Constituency Committee Presidents shall be ex-officio members, if they are not elected members. However the ex-officio members, if they are not elected members. However the ex-officio members shall not have voting rights. In addition, the District Working Committee shall nominate members

Party Cadres prescribed from time for a period of three years. The Party Cadres in each and every Branch under the jurisdiction of the respective Panchayat/Municipal/City Council have to elect councilors to the Council. In the absence of the Panchayat/Municipal/City level structure in any District, it is constituted by the elected members of the immediate lower structure in the hierarchy. The Panchayat/Municipal/City Council has to meet once in every six months. It will make a review of the Party situation in the constituency.

5.a) Panchayat/Municipal/City Committees.

The Panchayat/Municipal/City Committee is constituted by minimum 5 and not more than 15 members elected by the Panchayat/Municipal/City councils for a period of 3 years. The Branch Committee Presidents and Secretariat shall be ex-officio members, if they are not elected members. However the ex-officio members shall not have voting rights.

6. Branch.

The Party Cadres not less than 5 and not more than 28 persons shall constitute a Party Branch. All Party Members in the same jurisdiction shall be part of the respective branch.

7. Branch Committees.

The Branch Committee is constituted by office Bearers elected by the Party Cadres in the Branch for a period of three years. Number of elected members of working committees at every level shall be fixed by the next upper committee within the limit prescribed in the constitution for each term. But Executive Committee itself will fix the number of members to be elected to the Executive Committee and Office Bearers.

· Article VI

The Party Office Bearers at all levels except Branches shall be elected by the Executive Committee or Committee members at the respective level. Office Bearers of Branches shall be elected for election in all levels.

- 1. Natiojnal Level. The Executive Committee shall elect the following office bearers.
- a) President
- b) Vice President
- c) General Secretary
- d) Treasurer
- 2. State Level.

The State Working Committee shall elect the following office bearers.a) State President

- b) State Vice Presidents (Not more than 2)
- c) State General Secretary
- d) State Secretaries (Not more than 2)
- e) State Treasurer
- 3. District Level

The District Committee shall elect the following office bearers:

- a)District President
- b)District Vice President(Not more than 2)
- c)District General Secretary
- d) District Secretaries (not more than 2)
- e)District Treasurer

4. Constitutency Level.

The Constituency Committee

- a) Constituency President
- b)Constituency Vice Presidents(not more than 2)
- c)Constituency Secretary
- d)Constituency Joint Secretaries(not more than 2)
- e)Constituency Treasur
- 5.Panchayat /Municipal/City Level.
- a)Panchayat/Municipal/City President
- b)Panchayat/Municipal/City Voice Presidents(not more than 2)
- c)Panchayat/Municipal/City Secretary
- d)Panchayat/Municipal/City Joint Secretaries(not more tha2).
- e)Panchayat/Municiapl/City Treasury.
- 5.Branch Committee
- a)Branch President
- b)Branch Vice President
- c)Branch Secretary
- d)Branch Joint Secretaries(not more than 2)
- e)Branch Treasurer

However in the case of a Branch with minimum number of the cadres, There shall be only 3 Office Bearers; i.e. President, Secretary and Treasurer.

Powers and Duties and functions of Office Bearers:

Article-VII.

President.

- The President at all levels in that hierarchy shall supervise the activities of the party.
- He or she shall have the responsibility for the overall growth and development of the 2. Party under his jurisdiction.

Vice President.

- Vice President at all levels in the hierarchy shall assist the President and undertake the responsibility delegated to him/her by the President.
- In case of absence of the President from the routine functions, the President can appoint a Vice President as in-charge.

General Secretary.

- The General Secretary at all levels shall look after the general administration of the Party under the supervision of the President.
- In case there is more than one General Secretary, the concerned Executive/State Working 2. Committee can decide about the work distribution made amongst them.

Secretaries.

- The Secretary shall assist the General Secretary.
- In case there is more than one Joint Secretary, the concerned Committee can decide about the work distribution among them.

Treasurer.

The Treasurer at all levels in the structural hierarchy shall manage the income, expenditure and keeping the books of accounts of the party under the supervision of the General Secretary, in case there is not provision for General Secretary.

*The term of each committee including National Representative Council and all office bearers and members/councilors there of shall be three years.

*No Party member shall hold a position of profit in government and an Executive position in the Party at the same time.

*Election of the committees will be held by Show of Hands or by Secret Ballot.

SESSION OF THE PARTY

Article-VIII.

- a) Plenary Session
- The following persons from below shall be invited to attend the Plenary Sessions:
- All members of National Representative Councils.
- b) All members of State Representative Councils.
- All members of the Party in Parliament.
- d) All members of the Party in State Legislature; and
- e) Any other category of members agreed upon by the Executive Committee for the Session.
- A Plenary Session of the Party shall be held once in each year at such time and place as may be determined by the Executive Committee.
- The President of Executive Committee shall preside at the said session.
- Proof of dispatch of notice by ordinary registered post shall be considered as proof of invitation.
- B) Special Session.
- In addition to the annual Plenary session, any number of Special Session of the Party can
 be held if the Executive Committee so decide or if at least 60 members of the National
 Representative Council jointly make a request to the president of Executive Committee to
 convene such Session for the discussing an agenda specified in the request.
- 2. All members of the National Representative Council shall be invited to the Special Session.

POWER & JURISDICTION

Article-IX

- All ordinary decisions taken at a Plenary Session or a Special Sessions by ordinary majority shall be binding on all members and units of the Party.
- 2. National Representative Council shall be the highest policy body of the Party.
- 3. The Executive Committee shall be the highest decision making authority of the Party. Every power not specially vested in any other organ by the Constitutor by specific decisions of the Plenary Session shall be exercisable by the Executive Committee. It shall lay down rules for carrying out the functions of all units and organs. It shall frame rules

for the maintenance of funds which will be audited by a Chartered Accountant (empanelled by CAG) and approved annually. It shall be the duty of the Executive Committee to allocate the power of all other units and organs, to create machinery for holding elections and for settlement of disputes there from.

 All other organs and units shall perform such functions and carry out such duties in their respective areas as may be determined by the Executive Committee.

CENTRAL ELECTION COMMITTEE

Article-X

If and when the Party is registered by the Election Commission, the Executive Committee shall set up a Central Election Committee, as per rules for the purpose of making final selection of candidates for the State Legislatures and Parliament and conduct election campaign.

STATE ELECTION COMMITTEE.

Article XI

By framing necessary rules Executive shall elect a State election committee of not more that 7 months.

- a) To propose names of Party candidates for Legislature and Parliamentary seats from the State to the Central Election Committee.
- b) To make final selection of Party candidates for the various Body Elections, Cooperative institutions and the like and
- To conduct election campaigns in the State.

QUALIFICATIONS TO BE A PARY CANDIDATE

Articles-XII.

The executive committee shall prescribe a general format for application to be a candidate for elections on behalf of the Party. It will require furnishing of an asset statement and income tax statements of the Past 3 years, proof of Party experience of one year, proof of financial solvency, and proof of experience in public speaking and administration.

DISCIPLINERY ACTION/DISPUTE RESOLUTION Article-XIII.

- Disciplinary Action Committees of not more than 5 members will be constituted by the Executive Committee and State Secretariat respectively at the National and State levels. These Committees shall draw their own procedures.
- A State Disciplinary Action Committee can take action only against units subordinate to
 it and individuals other than Members of the National Representative Council and
 Members of Parliament.
- On receipt of a complaint for breach of discipline, the President of Executive Committee
 or the State President, if he or she so decides may suspend an individual or a Unit, Breach
 of discipline includes the following.
- A) Oppose the official candidate of the Party in elections.
- b) Willfully disobeying instructions or orders passed by a competent authority of the Party.
- c) Taking a Party dispute to any other agency outside the Party, and in particulars, acting in a way calculated to lower the fame, reputation and prestige of the Party or carrying on public propaganda.
- d) Collecting funds for the Party unauthorisedly, misusing the reputation of the Party or indulging in malpractices in enrolment of members or in the conduct of the Party elections.
- e) Any acts contravening the rules and regulations of the party.
- The DACS shall in particulars take strong action against any public functionary such a
 Minister belonging to the Party and found to prima facie guilty of corruption and misuse
 of power.
- No final decision for breach of discipline shall be taken against any individual or a Unit without an opportunity of being heart given to the individual of Unit concerned to explain and answer such charges as made against it or him/her.

- 6. The State President will forward the said complaint along with the explanation received there to be the individual or the Unit to the Disciplinary Action Committee which will submit its report to the President in the not more than two months.
- 7. The State President will ordinarily take action consistent with the recommendation of the Disciplinary Action Committee within one month. But if he or she so desires he or she may refer the said report for the consideration of his or her Executive within one month and there after action will be taken according to the decision of the Executive within one month.
- Any disciplinary action at the State level shall be reported to the President of Executive
 Any unit or member again.
- Any unit or member aggrieved by the disciplinary action taken by the State Unit may go in appeal within 15 days to the Central.
 - Disciplinary Action Committee which shall be disposed off within two months. But any appeal against the decision of a State Working Committee will be considered only in the next meeting of the Executive Committee.
- 10. Any member contesting election against the official candidate of the Party will be summarily expelled from the Party by the State President or the National President. The State President shall intimate the appellant about the decision taken on the report of the Disciplinary committee within one month.

VACANCIES

Article-XIV.

- Members absenting without approval for the meetings of their Unit will be liable to be removed by a resolution of the concerned Unit.
- President of a Branch ,Panchayat /Municipal/City/or a District Committee can be removed by a resolution passed by a 2/3 majority of the members present and voting in a meeting of the Unit concerned. Provided a written notice signed by not less than half of the members of the Committee is sent to the President of the concerned higher Committee, on receipt of which he or she will nominate an office-bearer/member of his committee to call an emergency meeting of the lower Committee under the nominee's chairmanship where notice will be taken up.
- A President can remove an office-bearer nominated by him/her only after a motion to the effect is adopted by his/her Committee.
- 4. President of Executive Committee or a State President can be removed by a resolution passed by a 2/3 majority of the members present and voting at a requisitioned meeting of the National Representative Council or the State Representative Council Committee as the case may be .
- To fill vacancy in any Committee or National Representative Council/State Representative Council remaining elected members of that body will be entitled to fill the vacancy.
- 6. Vacancy of the President of any Unit will be filled in the same manner as was done originally, till then an ad-hoc appointment will be made by the President of the higher body who in turn will nominate his office-bearers from amongst the members of the existing Committee/Executive.
- 7. No post will remain vacant for more than 6 months.

PARTY FUNDS & ACCOUNTS

Article-XV

- Fund collection receipts will be printed at the State and National level.
- Each receipt will be duly numbered and issued in books of account containing 25

 3. Each receipts.
- Each receipt shall bear a facsimile signature and seal of the concerned Treasurer. The counterfoil will be signed in full by the member who collects the money.
 Bank Account will to the concerned Treasurer.
- Bank Account will be opened in the name of the Party up to the Local Committee level to Secretary of the unit.
 The account
- The accounting year of the party shall be counted 1st April, to 31st. March, each and 3
 All presents
- 6. All properties of the party whether moveable or immoveable shall vests with the Executive Committee who shall responsible for the safe custody of funds and assets of the party. The funds shall be kept in any schedule bank as the committee may determine.
 7. Party funds to be settled.
- Party funds to be utilized only for political activities and Party will abide by the instructions issued by the Commission from time to time in the maintenance of its accounts.
- The party shall never take any funds from convicted criminals or from criminal syndicated or corrupt officials or others. Anyone who collects such funds will be referred to the respective.

DAC AUDIT

Article-XVI

Once at least in every year the accounts of the party shall be examined and the correctness of the balance sheet and the income and expenditure accounts shall be ascertained by one or more qualified Chartered Accountants on the panel of CAG.

And the party will submit its copy to the Election Commission within 6 months of the end of financial year.

All audited reports shall be placed on the internet and any citizen of India who wishes to inspect Party accounts shall be able to do so subject to procedures prescribed.

RESERVATION FOR WOMEN SCHEDULED CASTE SCHEDULE TRIBES, OTHER BACKWARD CLASSES AND MINORITES.

Article-XVII

- a) 25% of the seats in different Party Committees shall be reserved for women.
- b) Not less than 25% of seats shall be reserved in different committees for schedule caste, schedule tribes, other backward classes and minorities.

QUORUM

Article-XVIII

Quorum for all Committee/Executive meetings shall be one-third of the strength of the National, State, District, Constituency, Panchayat Municipal city, and Branch Level council or committe.

AMENDMENT OF THE CONSTITUTION

Article-XIX.

- The constitution can be amended except Article III (A), altered and added to only by the National Representative Council of the Party through a 2/3rd majority of those present and voting.
- In exceptional circumstances, the Executive Committee may, by unanimous decision, decide to alter any provision and that will comes into operation immediately, subject to its subsequent ratification by the National Representative Council.

POWER TO MAKE RULES

Article -XX

1. The Executive Committee through 2/3rd majority, has the power to make and amend rules as and when required, under the specific provisions of the Constitution.

MERGER/DISSOLUTION OF THE PARTY.

Article-XXI.

Any decision regarding the dissolution of the party or the merger of the party has to be taken in the Executive Committee meeting convened specifically meeting. However, any decision regarding the dissolution of the Party or the merger of the Party shall be in effect only after the approval in the Plenary session of the Party convened specifically for the purpose, by simple majority of the members present in the concerned meeting, within a period of two months from the date of the said decision in the Executive Committee.
